8. Date of formation of association: This association was established on May 14, 2004
by the Founder's meeting. State Registration
Certificate was issued on July 26, 2004 by the
Ministry of Justice and Domestic Affairs.

9. Objectives and ethics:

Is to map Mongolian territory, to establish national geodesy location and
spatial system, to provide geodesic digital and cartography information,
and it is a NGO which has variety of membership of individuals,
companies and is to give professional advice and support on state
running entities.

The association is also to protect member individuals and companies
rights, to express their reviews to the state and government, to make
better legal condition for implementing geodesy and cartography
productions and services and has active foreign activities for improving
member organizations' honesty on foreign market and encourages their
activities internationally.

Besides them, following activities are prior to the association such as to establish good collaboration with other professional organizations and international organizations of this field for studying their experiences, to introduce new technologies in this sector, upgrading specialists educational background, participate in meetings and seminars, making reports and statements.

Translated copies of the Regulation and structural sketch of the Mongolian Association of Geodesy and Cartography, State Registration Certificate, Confirmations and Certificates which are granted to member organizations are enclosed.

10. Routes of entry to membership

According to the Regulation of the Association, the member organizations are given confirmation Certificate of **“Member organization”**.

Member organizations which are entitled to receive Certificate of “Member organization” must be qualified with following requirements:

- At least have 5-10 engineers who have earned Bachelor or Master Degree from Domestic and international Universities. (for companies or organizations)
- Professional workers are referred to technical workers who have completed domestic professional schools or colleges.
- Above mentioned qualifications can be obtained from domestic academic institutes.
- Above mentioned bachelor and master degrees on this profession require 4-5 years academic years to be earned. And technical workers can be qualified within 2-3 years of college trainings.
- Major specialists and engineers of an organization or company must have minimum 3 years full-time work experience and professionally experienced.
- It is voluntary to continually updating professional education for someone, and an engineer who have at least 5 years work experience is entitled to be awarded by “Specialized engineer” and at least 15 years work experienced engineer can be awarded by “Consulting engineer” titles based on specific requirements in accordance with professional trainings organized by specific Ministries.
- There is not a conception of sub-professional members or technicians
- Other lower level specialists who are currently employed in this sector can be accepted as members in accordance with considerate observations related to their academic Diploma, their professional performances and professional skill on this field.

13. Statutory recognition

According to Mongolian legislation, This association is legally recognized organization awarded by the Certificate No: 4151 (Reg. No: 1041681) by the Ministry of Justice and Domestic Affairs.

Member organizations and individuals of the association carry out following activities on Mongolian territory:
