The FENEA - National Federation of Surveyors Engineers, representative maximum entity of this Professional class in the Brazilian Territory, founded on May 30, 1986, during I CONEA'S accomplishment - FIRST BRAZILIAN CONGRESS OF ENGINEERING OF SURVEYING, in Salvador - Bahia, is a civil society without lucrative ends, with duration for uncertain time, constituted as a legal entity of private right, it congregates in national level the entities Engineers Surveyors for coordination ends, defense of their rights and with ends of usefulness it publishes, it seeks the Good Social Ester and the returned professionals' formation stops the Very Common.

Its performance is fundamentally addressed in the sense of collecting, to articulate and to express the group of the professionals' claims acted by these Associations and Nuclei, seeking the obtaining of improvement of their life conditions and work, in the whole national territory, with purpose of to defend and to coordinate the interests, rights and prerogatives of the category, as it sets down the legislation in energy, with the objective of collaborating with the public powers, fighting for the interest the respective professionals' solidarity of its subordination to the national interests, FENEA acts in the sense of the consolidation of these entities as social and political, free and autonomous Institutions, struggling for the invigoration of these, and of the democratic participation and for the permanent intensification of their relationships with other classes and sections of the Brazilian society and with the State;

FENEA is also built to condemn and to maintain technical and scientific exchange with organizations and other tied international class entities the Engineering of Surveying, that they are devoted to the development of the Surveying Engineering and the improvement of the work quality. In this sense, it accomplishes every two years, its largest Event: CONEA - National Congress of Surveying Engineering, in the intention of developing activities gone back to the professionals' of the Engineering of Surveying improvement, where for occasion of the accomplishment of IIICONEA it was the inspiring source of the elaboration of the technical norms of topographical services, that this permanently focused in the Brazilian social needs, assisted by the profession. Besides, it supports the accomplishment of other events State and/or Regional promoted by adopted entities and similar.


FENEA congregates seven state class entities now (Bahia, Mato Grosso do Sul, Minas Gerais, Piauí, Santa Catarina, to São Paulo) and a regional association (Regional of Araraquara), representing the interests of the category nationally. In case other grouping of Surveyors Engineers wants to participate actively and/or to form a new association or nucleus joining to our movement, these should seek the surveyors engineers of its state association or communicate directly with FENEA.

■ OBJECTIVES OF FENEA

- a) To congregate and to act in every national territory and out of him, the regional and sector's state entities of the Engineers active Surveyors in his/her territorial base and to contain the professionals of this category in States where such representative associations don't exist. All to contain the professionals' of the Engineering of Surveying modalities: salary earners, autonomous and enterprising and also for specialty, in way to unite this class strongly in all his/her extension and for every National Territory, promoting his/her mobilization, in search of his/her professional valorization through the full exercise of the profession, always defending their interests and individual and collective rights in any instances, before judicial authorities, defending the technological development and cultural partner;
- b) To promote the dynamics of the representative entities, motivating the effective participation of all yours adopted yelling for the union and solidarity, in the discussion process and decision, seeking the invigoration of the professional category and larger conviviality among all of the representative organs of Engineering of Surveying in every national territory;
- c) To give prestige to and to promote Engineers Surveyors' organization in the work places and

areas stimulating to extend the creation of professionals' of the category groupings, seeking to the foundation of new Entities of the class in all States of the Federation, as well as the creation of regional and of sectors associations, that you/they seek the collective interest of the category, the consolidation and the invigoration of the Class, and the form of participation of the Federation in these institutions should be approved in Extraordinary General Assembly especially summoned stops this end;

- d) To struggle for the establishment of new Courses of Engineering of Surveying in all States of the Federation through institutions public or private;
- e) To defend the elevation of Engineer Surveyor's cultural and technical level and for his/her wide participation and decisive in the solution of the basic problems and of the Brazilian population, with the width that checks him/her his/her condition of private entity, with the free performance he/she wants in the extent of the category, he/she wants in the political extent;
- f) To focus, through technical events and other actions, permanent aspects of the knowledge of the themes of the surveying engineering, always seeking the National Development, the Integral Defense of the Brazilian Society and also to fight for a technical support of surveying engineering the layers of low income of the population and for an effective presence of the profession, close to the public powers and in the programs of Development of the Country, in all of the tasks that involve the study and the project regarding the performance of politics agrarian and in the control for preservation of the I dirty atmosphere.
- g) To endeavor efforts close to the fiscal organization of the Professional Exercise stop to obtain the casts' of suitable attributions fixation with the importance of the Engineering of Surveying. To publish the Code of Ethics and to demand for his/her unrestricted obedience. To collaborate with the Pubic Powers in everything that is within his/her reach.
